Statement of **RICH MCINNIS**, Candidate for Supervisor, 2nd District County of Santa Cruz

Occupation: Owner/Manager of The Seabreeze Tavern

I bought the Seabreeze from Santa Cruz County in 2005, and spent a year restoring the building. I was approved by the ABC for a liquor license (includes background check). Santa Cruz County Planning informed the ABC that the Seabreeze had "no right to use" and stopped my liquor license.

I met with my Santa Cruz County Supervisor and planning and was told they would red tag the Seabreeze if I used the building until I went through a level 5 permit process to get the "right to use" back. I was told the process would take 3 months. It took 10 months and cost me 177K dollars to pay the fees, mortgage and property taxes while the last pre-recession summer of 2007 passed.

On labor day 2007, I was allowed to open with no money left to buy inventory, hire employees or advertise. I had to file bankruptcy to stop foreclosure while I worked on a loan modification. I was cited by the fire marshall and decided to run when I got sued by planning again.

If elected, I will help businesses, homeowners and residents who are caught in the counties revenue trap(s). I will make myself available to meet on evenings and weekends.
