All references are to the California Elections Code unless otherwise noted.

Calendar Key – “E” stands for Election. The minus sign and the number after “E” indicates the number of days until the election. The plus sign and the number after “E” indicates the number of days after the election.

If there is an asterisk by the date, the date falls on a weekend or holiday; so the date listed is the next business day.

<p>Jan. 4* – Feb. 10 (E-158 to E-118)</p>	<p>Signatures in Lieu of Filing Fee – Judicial Candidates Between these dates a judicial candidate may obtain signature-in-lieu forms from the county elections official for circulating petitions to secure signatures in-lieu of paying all or part of the filing fee. Signatures may also be applied to the nomination signature requirements for office. §8061, 8105, 8106</p> <p>The In-Lieu Petition must be filed by the last day to file the Declaration of Intention since the filing fee must be satisfied by that day. The Elections Department will notify the candidate of any deficiency within 10 days of filing.
