For over 130 years, Lakeside has provided the children of our community with an exceptional education. Students are excelling in all areas.

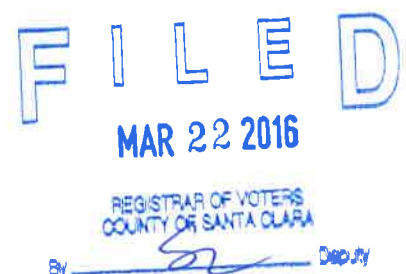
