Our high schools are among the best in the country because we are fortunate to live in communities that value top-quality education.

Fact: Measure A does not increase taxes. It simply extends local funding that cannot be taken by the State. Without Measure A, approximately \$1 million annually would be cut from our schools' budget.

Fact: These funds support high-quality science, math, technology, engineering and core academics, retain our highly qualified teachers and prepare our students for college and careers – not a penny can pay for administration.

California's state public education tax is set to expire soon, which will dramatically reduce state funding to our local high schools by nearly \$1 million.
