## All references are to the California Elections Code unless otherwise noted.

If there is an asterisk by the date, the deadline falls on a weekend or holiday and, in most cases, has been moved to the next business day.

## Signatures In-Lieu of Filing Fees – Independent Candidates Running for U.S. Senate, Congress and State Legislative offices

During this period, a candidate for U.S. Senate, Congress and State Legislative offices may obtain his or her forms from the county elections official or the Secretary of State for circulating petitions to secure signatures in lieu of all or part of their filing fee.
